#### Closure of the Schroder Institutional Index Linked Bond Fund

Further to our letter of 8 July 2016 I am writing to inform you of our intention to close the Schroder Institutional Index Linked Bond Fund (the Fund), in which you are invested.

# Why is the Fund closing?

The Fund's net assets have decreased to a level where it can no longer be managed effectively and is no longer commercially viable. We consider it unlikely that the Fund's assets will increase to a size which improves its ongoing viability in the foreseeable future, so we have decided to close it Please note that the winding-up of the Fund does not require unitholder approval.

The closure of the Fund will take place on 9 March 2017 (the effective date). In the days leading up to the effective date, it may be necessary to begin selling down the portfolio This means that, over this period the Fund may not be managed in line with its published investment objective.

### What will happen to my investment?

As an investor in the Fund you have two options:

## 1. Switch offer

You may switch your investment to any fund in the Schroders fund range into which you are eligible to invest While there is no charge to switch your investment, a dilution adjustment may be applied to both the sale of your units in the Fund and the purchase of units in any Schroders fund(s) which you are switching into. In order to switch your investment we will need to provide you with the Key Investor Information document(s) for the fund(s) that you wish to transfer to, along with an investment amendment form which should be completed and returned to us by 12 noon on 2 March 2017. You can request the investment amendment form and relevant Key Investor Information document(s) atwww.schroders.co.uk/switchor by calling our Investor Services team on 0800 718 777.

Alternatively, please speak to your usual financial adviser.

# 2. Redeeming your holding

If you wish to redeem your units in the Fund you must do so before 12 noon on 2 March 2017. Your units will be redeemed at the price calculated at the next valuation point of the Fund following receipt of your instructions. The proceeds will be sent to you within four working days of the redemption.

If you wish to redeem your units, you can do so by calling our Investor Services team on 0800 718 777 or by sending a signed written instruction to Schroders, PO Box 1102, Chelmsford, CM99 2XX.

If you do not switch or redeem your holding before 2 March 2017, the procedure explained in section (3) below will commence and, from that point, you will not be able to deal in units of the Fund. After the date of this letter the Fund's manager may not accept further subscriptions for units in the Fund.

# 3. Winding up and realisation of assets

Dealing in the units of the Fund will close at 12 noon on 2 March 2017. If you have not given us instructions to redeem or switch your holding prior to 12 noon on 2 March 2017, your units will be redeemed at the price calculated at 12 noon on 9 March 2017 less a retained amount to cover outstanding debtors and creditors of the Fund. The current accounting period of the Fund will end at 12 noon on 9 March 2017 and an additional interest distribution and interest accumulation will take place, with the interest distribution to be paid to unitholders on 9 May 2017. Following the Funds closure, there will be no further interest distributions or accumulation of interest.

The Trustee will then request that the Financial Conduct Authority (the FCA) revokes the Fund's authorisation order.

## 4. Outstanding monies

Once the Fund is closed, if there is any cash remaining in the Fund, a further payment will be made to unitholders who were invested in the Fund on 9 March 2017. Please be advised that if this second payment amount is less than £5 per investor, we reserve the right not to distribute such an amount but instead to donate it to a charity of our choosing. If there is a cash shortfall, this will be covered by Schroders.

### 5. Costs

With the exception of those costs related to the realisation of the Fund's underlying assets described in section (3) above, the costs of closing the Fund will be borne by Schroders.

The audit fee which is incurred from the closure date to the completion of winding up of Schroder Institutional Index Linked Fund will be paid by Schroder Institutional Index Linked Fund.

#### 6. Taxation

A redemption of units and a switch of holdings into any other Schroders funds will both be treated as a disposal for UK capital gains taxation Any interest distributions, above the threshold referred to in section (3) and paid on or before 5 April 2017 will be made net of basic tax rate. Where interest distributions are paid after 5 April 2017, these will be paid gross. If you have any doubt about the tax implications of the winding up of the Fund or any prior sale of units then you should consult your financial or tax adviser.
