Your attention is drawn to the change in **5% Redemption Penalty Free Withdrawals** and **Minimum Amount of Redemptions**. Please be advised of the following changes affecting this Fund for all instructions relating to the 30 September 2014 dealing point and forward.

5% Redemption Penalty Free Withdrawals

The Fund Directors have taken the decision to implement a single annual request policy with respect to all 5% redemption penalty free withdrawals. To assist investors, on receipt of their single annual request, an investor will be advised if the amount being applied for is below the annual entitlement and will be informed of the total annual amount available; the investor may resubmit their request. It should be noted that the 5% redemption penalty free withdrawal cannot be combined with redemption withdrawals over the 5% annual amount and the Fund will require separate instructions.

Minimum Amount of Redemption

The Fund Directors have taken the decision to implement a minimum level for redemption requests, excepting the condition(s) laid out below:

- a. the total holding in the Fund by an investor is less than the minimum level aforementioned; or
- b. the investor is applying to take an annual 5% redemption penalty free withdrawal and the amount is less than USD one thousand dollars (USD \$1,000.00).

Redemptions which are, after any applicable penalties, less than a financial payment of USD one thousand dollars (USD\$1,000.00) or currency equivalent will not be accepted by the Fund
