Proposed Fund Closure

Where similar strategies exist across a number of funds, or funds are deemed to be too small to be managed efficiently, GAM may seek to rationalise or streamline any such funds if GAM believes it is logical and in the interests of the relevant fund's shareholders to do so.

In this context, GAM and Wadhwani Asset Management (www.waniasset.com), the Investment manager of the GAM Star Keynes Quantitative Strategies (the "Fund") have, by mutual agreement, decided to end their partnership. As a result and in accordance with the Memorandum and Articles of Association of GAM Star Fund Plc¹, all shareholder positions will be redeemed on 15th November 2018.
