## **Change of Custodian**

The Company entered into a Custodian Agreement, dated 1 October 2014, with Deutsche Bank International Limited (Guernsey branch) ("Deutsche Bank") under which the Company had appointed Deutsche Bank as Custodian of the Funds. On February 15, 2018, the Bank of N.T. Butterfield & Son Limited ("Butterfield") announced that it had entered into an agreement to acquire Deutsche Bank's banking and custody business in the Cayman Islands, Jersey and Guernsey.

As a result of this acquisition by Butterfield, the Company has signed a Novation Agreement, dated 25 February 2019, with Butterfield and Deutsche Bank, pursuant to which Butterfield will replace Deutsche Bank as Custodian of the Funds with effect from 25 February 2019. Please be advised that the Novation Agreement maintains the same terms and conditions of the Custodian Agreement between the Company and Deutsche Bank.
