Important information about changes to your investments with Janus Henderson

We are writing to you regarding your holding(s) listed in Appendix A (your "Investments") to give you advance notice that we will be moving each class of your Investments to a new, cheaper 'E' share class / unit class ("E Class").

Why are my Investments being moved to an E Class?

In the past, fund fees were set at a level which included payments to financial advisors who would receive part of the management fee as payment for their advice. This is the case for your Investments, listed in Appendix A. However, our records indicate that you do not use a financial adviser for these Investments and could therefore benefit from being in a class with a lower fee. As a result of recent changes to the guidance published by our regulator, the Financial Conduct Authority (FCA), we are now able to move each class of your Investments (shown in Appendix A) to a new, cheaper E Class that we will be launching specifically for this purpose.

What are the benefits of moving to the new E Class?

The benefit of moving to the new E Class will be a lower management fee. Otherwise, the E Class will have the same fundamental features as your existing class (including distribution dates and whether income is paid out to you or accumulated in the fund). The level of the management fee reduction will vary by fund. The new, lower management fee reflects the fact that there is no payment to a financial adviser. The management fee for each new E Class is listed in Appendix A.

How will you be affected?

If you take no action, your Investments will automatically be moved to the relevant new E Class on the dates indicated in the table (the "Effective Dates"). You will still be invested in the same fund(s), in a class with the same fundamental features. All that is changing is that the new E Class that you will hold will have a lower management fee. Additional details of the new class (including name, identifier and management fee) are also shown in Appendix A. Confirmation of your new class will be sent within 14 business days following the conversion(s).

Based on the current UK tax legislation and HMRC practice, the move to the new E Class will generally not constitute a taxable event for UK investors. However, investors may wish to seek their own independent, professional tax advice to consider their own personal circumstances. Please note, investments that are held within an ISA will not have their ISA status impacted by this change.

If you hold a regular savings plan you do not need to take any action, as we will update this to ensure your regular saver contribution is invested into the new class.

If you do not want your investments to be converted into an E Class, you may switch to another fund or convert your holdings into a class that is <u>not</u> listed in Appendix B. You may also redeem out of the class. Any switch, conversion or redemption must be made before the cut-off date listed in Appendix A (the "Cut-off Date"). Please note, if you switch, convert or subscribe into any investments listed in Appendix B before the Cut-off Date, your new investment will still be converted into a new E Class on the marked effective date for the relevant class. Furthermore, please note that any switch or redemption may affect your tax position. If you are in any doubt about your tax position, you are recommended to take professional advice.
