We are writing to you because you currently have an agreement in place with Polar Capital LLP (hereinafter "Polar Capital", "we", "us", "our") relating to the distribution and management fee rebates for the following funds managed by Polar Capital (the "Agreement"):

- 3. Nothing in this letter shall entitle you to receive any rebate on any Funds that do not appear within your Agreement.
- 4. Nothing in this letter constitutes an offer to invest in any of our Funds and does not constitute a financial promotion.
